For: Reducing the speed limit on Ginguite Trail, Pintail Trail, and Pintail Court to 15 MPH.


Discussion:

- 1) The current speed limit on Ginguite Trail, Pintail Trail, and Pintail Court is 25 MPH although all are residential streets and Pintail Court is a short cul-de-sac.
- 2) On all streets there are no sidewalks/bike paths for pedestrian or bike traffic.
- 3) All streets are barely wide enough for two cars to pass.
- 4) Pintail Trail is a straight street, but when completed later this year, traffic to All Saints Episcopal Church will be turning south approximately half-way down the street into the expanded parking area, creating congestion.
- 5) Ginguite Trail has curves and hills with limited visibility to hazards such as pedestrian or bike traffic, or children playing on or near the street with skateboards, etc..
- 6) Families living on these streets as well as South Dogwood often use them for walking exercise.

Petition:

The undersigned homeowners or tenants of property on Ginguite Trail, Pintail Trail, or Pintail Court hereby petition the Town Council to reduce the posted speed limit on these streets to 15 MPH as soon as possible.
