## National Peace Officer Memorial Week May 10 - 17, 2010



In 1962, President John F. Kennedy signed a proclamation which designated May 15th as Peace Officers Memorial Day and the week in which that date falls as "Police Week". Every year since, tens of thousands of law enforcement officers from around the world converge on Washington, DC to participate in a number of planned events which honor those that have paid the ultimate sacrifice.

The first official memorial service took place on May 15, 1982. On that date, approximately 125 people gathered in Senate Park to honor 91 law enforcement officers. Over the past 22 years we have honored over 3,000 law enforcement officers from around our nation. Today, the National Peace Officers' Memorial Service has become one in a series of events which includes the Candlelight Vigil, which is sponsored by the National Law Enforcement Officers Memorial Fund (NLEOMF) and seminars sponsored by Concerns of Police Survivors (COPS).

The NC Attorney General's Office Annual North Carolina Peace Officers Memorial Day Ceremony will be held on Tuesday, May 11, 2010, 11:00 A.M. at the Tanglewood Church, 2103 Rouse Road, Kinston, NC 28504. Representatives from all North Carolina Law Enforcement Agencies are encouraged to attend and the general public is invited to share in this auspicious occasion.

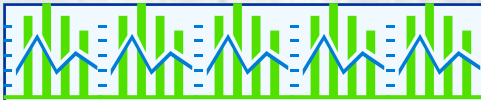
04/20/2010 - Larceny @ 1 1st Avenue - a pool motor was removed by unknown person(s) from this location.

## Use of Low-Speed Vehicles

### § 20 121.1. Operation of a low speed vehicle on certain roadways.

The operation of a low speed vehicle is authorized with the following restrictions:

- (1) A low speed vehicle may be operated only on streets and highways where the posted speed limit is 35 miles per hour or less. This does not prohibit a low speed vehicle from crossing a road or street at an intersection where the road or street being crossed has a posted speed limit of more than 35 miles per hour.
- (2) A low speed vehicle shall be equipped with headlamps, stop lamps, turn signal lamps, tail lamps, reflex reflectors, parking brakes, rearview mirrors, windshields, windshield wipers, speedometer, seat belts, and a vehicle identification number.
- (3) A low speed vehicle shall be registered and insured in accordance with G.S. 20 50 and G.S. 20 309.
- (4) The Department of Transportation may prohibit the operation of low speed vehicles on any road or highway if it determines that the prohibition is necessary in the interest of safety.
- (5) Low speed vehicles must comply with the safety standards in 49 C.F.R. § 571.500. (2001 356, s. 5.)
