Southern Shores Hires 52 Officers

Since its inception in 1979, the Southern Shores Police Department has hired no less than 52 employees. Of those 52 employees, only one retired from the town, three passed away while employed here and the rest have been lost to other departments or professions. The turnover rate for police officers is very high particularly in small towns that often cannot compete with larger departments in salary, benefits or excitement. While the Southern Shores Police Department has had a tumultuous employment history with many of its previous employees only remaining a year or two, we are proud to say that over half the current staff has now been with the department five years or more!

At the September 6th council meeting, Sgt. Jonathan M. Slegel was recognized for 10 years of service to the Town of Southern Shores. Sgt. Slegel began work with the Southern Shores Police Department in late August of 2001. He came to us from the Edenton Police Department and has been a valuable addition to the Southern Shores family. Additionally, Lt. Paul W. Terry came to us in December of 2001 after serving many years with the Town of Nags Head. This December will mark Lt. Terry's 10th year with Southern Shores and during that time has proved himself to be invaluable to this department. Jennifer P. Couture, the department's administrative assistant, has been with the town for 12 years as of September 1st as is the second longest currently employed member of the Town of Southern Shores. Officer Darrell T. Brickhouse has been with the department 6 years and Sgt. Dean R. McManus and Officer/Investigator Michael A. Torres have each been with us 5 years. Chief David M. Kole and Officer Jeremy R. Hemilright will reach their 5 year mark next year.

E-Mail Scams

People are becoming increasingly dependent on technology for all facets of life: social interaction, finances and purchasing everything from entertainment to clothes to groceries. As such, criminals are coming up with even more inventive and effective ways of separating us from our money. Most everyone that has access to the internet has an email account which is a quick and easy way for criminals to reach out and touch the masses. Probably everyone who uses email has seen an email scam at one time or another. They come in many forms and use a variety of methods to obtain a victim's personal information. The most common method of doing this is by phishing or spoofing.

"Phishing and spoofing are somewhat synonymous in that they refer to forged or faked electronic documents. Spoofing generally refers to the dissemination of email which is forged to appear as though it was sent by someone other than the actual source. Phishing, often utilized in conjunction with a spoofed email, is the act of sending an email falsely claiming to be an established legitimate business in an attempt to dupe the unsuspecting recipient into divulging personal, sensitive information such as passwords, credit card numbers, and bank account information after directing the user to visit a specified website. The website, however, is not genuine and was set up only as an attempt to steal the user's information." (This information was obtained from the Internet Crime Complaint Center.)

Email, while a useful tool, should be handled with care. If possible, do not open email from senders you do not know. If you think you know the sender and open the email but it doesn't make sense or seems strange in some way, DO NOT open any corresponding attachments unless you know the email was intentionally sent to you by the sender. If you receive an email from a business, bank or other financial institution that you do not do business with, do not respond to it. Even if you receive an email from an business that you do business with, do not use links in emails to access their website or open attachments. If you have business to conduct online, do so by going directly to the website of the business in question.

If you think you might be the victim of an email scam, you can file a complaint with the Internet Crime Complaint Center at www.ic3.gov. You can also go to their website for more information regarding the different type of internet related crimes and ways to protect yourself against becoming a victim.
